

2021 Fisher Community Fair Talent Contest Rules

(Professional entertainers are not eligible as defined in rule #1)

PLEASE THOROUGHLY READ AND UNDERSTAND ALL RULES!

PAY SPECIAL ATTENTION TO RULES 1, 3, 4 AND 9!

1. A professional entertainer is someone who has a lot of experience or skill in a particular job or activity. For this contest you **may not participate** if you have been paid fees for performing in your area of talent. **Example:** A dancer who has been paid may enter as a singer. The dancer may not enter as a dance contestant. Engaged in a specified activity as one's paid occupation rather than as a pastime/
2. The entry or act cannot be a current winner for another county or community fair, for the 2019 year.
3. Any act that performs over a 4-minute time limit will be disqualified. **Contestant is not to give an introduction to their act.** The MC will announce all acts.
4. Age limits each division:
 - A. **Junior Division:** All contestants can be 14 years old or younger on the day and date of the local contest. Junior division contestants can be 15 years old when competing at the State Level in January, if they met the age requirements at their local contest.
 - B. **Senior Division:** All contestants cannot be over 21 years of age on the day and date of the local contest. Senior division contestants can be 22 years old when competing at the State Level in January, if they met the age requirements at their local contest.
5. A piano or keyboard and floor mike will be the only equipment provided.
6. The panel of judges' decisions will be final.
7. There will be a setup time limit of 3 minutes per act. This will be controlled.
8. To lesson sound prop confusion. When using a CD taped accompaniment, only the song the contestant is using shall be on the CD. **No like talent is allowed on the recording. ie. vocal, tape dancing, any like instrument, etc.** This will be carefully monitored.
9. Entries and fees must be received by July 8, 2021. No late entries will be accepted.
10. **An entry fee of \$10 must accompany all entries.**
